Chairman Graduate Studies briefed the GSMC members that on the directives of Pro-Vice Chancellor (Acad:), the case of Mr. Simon Bashir, M.Phil Scholar at Balochistan, Study Center (Islamic Studies), vide registration No. 1996/UB-2014/Q-1310 for submission of M.Phil thesis which is late due to the bomb blast on the Church which made him and his family members injured to Graduate Studies Monitoring Committee (GSMC) for deliberation & review. The deliberation and recommendation to be placed before AS&RB for final approval.

**Resolution:** The Board resolved that in continuation with the previous date i.e. 15<sup>th</sup> April, 2020 all candidates of time bared cases will be allowed to submit their applications within 2 months' time i.e. till 15<sup>th</sup> June, 2020. Subsequently all applications will be placed in upcoming Academic Council for approval because decision made by Academic Council vide letter No. 287/30-AC/Acd:(19), dated: 9-12-2019 in its item No. 4, allowed only those 52 scholars whom thesis were placed in the meeting.
